Federal law requires specific information related to refrigerant use to be documented and retained for a minimum of 3 years. Purchase records of refrigerants used in units with over 50-pound charge must be retained for 5 years. UC San Diego uses the Refrigerant Compliance Management program (see below) to comply with recordkeeping requirements.

Refrigerant Compliance Program

A refrigerant is a substance or mixture, usually a fluid, used in a heat pump and refrigeration cycle. In most cycles it undergoes phase transitions from a liquid to a gas and back again. Many
