The management of operational risk essentially requires the ability to track and monitor performances of specified operational processes and systems. The operational risk management system also has to maintain databases of operational loss experiences. Internal controls and internal audits are used as the primary means to mitigate operational risk.

The three “Lines of Defense” in the Basel Model for Operational Risk Governance. The Basel Committee defines operational risk as “the risk of loss resulting from inadequate or failed internal processes, people and systems or from external events.”. It includes legal risk but excludes strategic and reputational risk.

Operational risk is seen as a risk that cannot be avoided and comes as a consequence of doing business. From a semantic point of view, rather than setting an appetite, practitioners speak of setting a tolerance for operational risk. Defining tolerances for operational risk is a key step in building a robust operational risk management framework.
